Annexure-II: Corrigendum to the pre-bid meeting for the RFP: Development and Maintenance Science and Innovation @Bharat

Modification in clauses

1. Modification in Section 2: Instruction to Bidders, (6) Issue of Work Order

6.4 On acceptance of the work order, the selected bidder shall submit an undertaking and Performance Bank Guarantee (PBG) of 3% of project value (development charge + maintenance of portal for two years + security audit charges) to O/o PSA to GoI valid till the completion of the project including technical support and two (2) years maintenance period and submission of security audit certificate from National Informatics Centre (NIC) approved/accredited security auditing agency.

2. Revision in Section 2: Instruction to Bidders, Instruction to Bidders, (7) Payment Terms, (7.1)

7.1 main clause: Payment shall be released as per acceptance of deliverables given in the following table, within 45 days of the receipt of invoice along with supporting documents by the office, as per subject to deduction of applicable liquidated damages (till "Go Live") or SLA penalties (post "Go Live"), as far as possible.

3. Revision in Section 2: Instruction to Bidders, Instruction to Bidders, (7) Payment Terms (7.5)

All payments will be made through electronic mode only and where applicable, Bidder shall mention applicable taxes in a separate line item in the invoice in Indian Rupees.

4. Modification in Section 2: Instruction to Bidders, (11) General Terms and Conditions

7.5 O/o PSA to GoI intends to build this project preferably within 2-3 months' time. The project will be developed in phased manner as per proposed solution architecture in agreement with the O/o PSA.

5. Modification in Section 2: Instruction to Bidders, (11) General Terms and Conditions

11.19. Bidder shall strictly adhere to the timelines in relation to the proposed project plan. All endeavours should be made to complete the project within specified timelines. In case of delay in the deliverables, for the reasons attributable solely to bidder, penalty of 0.5 % of total project cost per two months shall be levied. Maximum penalty shall be 10% of the total project cost.

Bidder shall be excused and not be liable or responsible for any delay or failure not attributable directly to the bidder.

6. Modification in Section 2: Instruction to Bidders, (12) AMC Conditions

Addition of following line in section 2 clause under AMC condition 12 (8):

Penalty for System Availability SLA will be as per penalty terms as defined in the table. However, the overall penalty for a service performance period will be limited to <10%> of the value of services provided for that performance period.

7. Modification in Section 3 Non-functional requirements 3.2. (2) (e) on the number of users of the Innovation Platform:

- Besides the optimistic estimate of the number of users as given in a table 3.2(2) (e) (i); a more conservative estimate of the number of users in Year 1 may be taken as 25,000 to 30,000. The number of users may spike up based on participation in a specific event.
- The conservative number of users could be a reference for sizing for application performance. However, while doing so, bidders should also continue to keep in mind Section 3.2. (2) (f).
